Dear Sir,

- Please find enclosed herewith RIL PP Basic Price w.e.f. 01.04.2017 6:00 Hrs.– as per Annexure – I & II & III
 - Excise Duty: Extra as applicable on time of delivery.
 - Sales Tax /CST/VAT: Extra as applicable from time to time.
 - Ex- Works Sales: (a) Goods will be dispatched on freight to pay basis to be paid directly by the customer to transporter. (b) Incase customer desires RIL to arrange transportation, the freight will be collected in the invoice along with the service tax required to be paid thereon. In that case the GC note / LR shall be issued showing PLST as “Consignor” and the service tax recovered from the customer will be discharged by RIL accordingly.
 - Freight List for Ex- Works Supplies w.e.f. 01.01.2017 for Ex-Depots Sales: Insurance & Freight & Service tax to be arranged / borne by the customer.
 - Octroi and / or any other local levies will be borne by the customer themselves.
 - Cash Discount of Rs.800 PMT on Ex-Works and Ex-Depot sales. For Ex-works sales it shall be deducted from Basic Prices for payment of excise duty. Cash Discount is applicable for all grades except plant sweeping and waste. E P I will be Rs.80/MT/Day for payment received before the due date subject to a maximum of 9 days

Trade Discount – Regional would be given on Ex-Works supplies for customers located in certain zones

Deemed Exports :

Deemed Export Sales will only be direct sales, assisted by DCAs.

For Deemed Exports (incl SEZ)

- a) For Credit Price: 5 days interest free credit period. Payment has to be made through e-payment / other approved payments.
- b) For Cash Price: Payment on next working day from the date of Invoice. Payment has to be made through e-payment / other approved payments.
- c) For supplies under Letter of Credit: 10 days interest free credit period for Customers

Fixed Price policy shall be applicable both on LC payment and E-Payment modes.

- If supplies are against LC – Contract price will apply for entire month on LC qty's locked in the system upto 5th of the month, subject to receipt of LC not later than 8th of the month.
- If supplies are against E-Payment – Contract price will apply for entire month on E-Payment qty's locked in the system upto 5th of the month.
- For Operating Guidelines and other Customer – DCA commitments and clauses please refer to our Detailed DE Fixed Price Policy note.
- Grade wise Ex works Deemed Export prices for HZ, JG, BC & NC are as per Annex. V subject to their complying with the procedures for obtaining supplies with reference to advance licenses.
- Deemed exports are not eligible for cash discounts, CD - EPI, Trade discount and any other discounts. The policy of no TD -Quantity on Deemed Export continues and Deemed export qty shall not be clubbed with Domestic sales.
- It is re-emphasized that the full (duly checked) set of deemed export documents should be received at HO for processing as per the guidelines issued.
- CST/ VAT will be charged extra as applicable.
- Excise duty liability (For 44/2001 supplies & EoU supplies) will be calculated on contracted transaction value and CST/ VAT will be charged extra as is applicable at the time of delivery.

Price ruling on date of dispatch will be applicable, and supplies are subject to Grade availability. All other terms and conditions remain unchanged.
